NOTIFICATION

In exercise of the powers conferred by proviso to article 309 of the Constitution of India, the Governor, Himachal Pradesh, is pleased to make the following rules further to amend the General Provident Fund (Central services) Rules, 1960, in their application to the State of Himachal Pradesh, namely:-

Short title and  
Commencement.

1. (1) These rules may be called the General Provident Fund (Central services), Himachal Pradesh Amendment Rules, 2023.

(2) These rules shall come into force from the date of their publication in the Rajpatra (e-Gazette), Himachal Pradesh.


Substitution of rule 4.

2. For rule 4 of the General Provident Fund (Central services) Rules, 1960, the following rule shall be substituted, namely:-

“4. Conditions of eligibility- All temporary Government servants after a continuous service of one year and all permanent Government servants shall subscribe to the Fund:

Provided that a Government servant appointed during the period between 15.05.2003 and 31.03.2023 and who has opted to continue under the contributory Pension Scheme (National Pension System), shall not be eligible to subscribe to the Fund:

Provided further that a temporary Government servant, who is born on an establishment or factory to which the provisions of Employees' Provident Funds Scheme, 1952, framed under the Employees' Provident Funds

and Miscellaneous Provisions Act, 1952 (19 of 1952), would apply or would have applied but for the exemption granted under Section 17 of the said Act, shall subscribe to the General Provident Fund if he has completed six months' continuous service or has actually worked for not less than 120 days during a period of six months or less in such establishment or factory or in any other establishment or factory to which the said Act applies, under the same employer or partly in one and partly in the other.

**EXPLANATION.-** For the purposes of this rule "continuous service" shall have the same meaning assigned to it in the Employees' Provident Funds Scheme, 1952, and the period of work for 120 days shall be computed in the manner specified in the said scheme and shall be certified by the employer.


**NOTE 1. -** Apprentices and Probationers shall be treated as temporary Government servants for the purpose of this rule.

**NOTE 2. -** A temporary Government servant who completes one year of continuous service during the middle of a month shall subscribe to the Fund from the subsequent month.

**NOTE 3.-**Temporary Government servants (including Apprentices and probationers) who have been appointed against regular vacancies and are likely to continue for more than a year may subscribe to the General Provident Fund any time before completion of one year's service."
